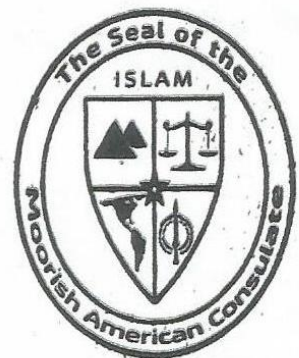

Fayetteville Police Department, Officer Torre, Cumberland County Sheriff Department, Chandra Quaye, Harvest Moon Properties LLC, and Cumberland County District Judge and Small Claims Magistrate

All violate international human rights of indigenous people. United Nations Declaration on The Rights of Indigenous People Treaty protects the right of indigenous to redress all matters pertaining to their lands; and the right to return to their lands unencumbered.

Public Law House Resolution 280: The State of North Carolina has not jurisdiction in any civil or criminal matters involving indigenous indians ab original people.

On Monday January 27th 2020 I was arrested for a failure to appear in Cumberland County Superior Court on failure to register a vehicle with the State of North Carolina DMV,. The conveyance a 2000 Astro Van was registered with Yahudah Washitaw of East Terra.

After kidnapped in the Cumberland County Jail for 3 days I made bail, but the computer, phone and tribal documents with me on the night of the 27th were not returned.

I went down to the Fayetteville Police Department Friday January 31<sup>st</sup> 2020 to retrieve tribal property and I was told that the arresting


officer must come in and sign for the release of the items which included my keys to my conveyances and trailers and etc.

Upon returning to the tribal property 300 Rodie where I abode I found the house padlocked and a Sheriff sign in the window stating do not enter.

I received paper laying around the yard on 24th requiring us to vacate the property, yet I never received a notice of a hearing. On February 2, 2020 while collecting items from the property Chandra Quaye call the Sheriff to come and arrest me because I refused to converse with her.

On Monday February 3rd 2020 I was told by the Fayetteville Police Department that they must wait for the officer to release my property after a judge signs off; although there was not a search warrant to seize our property. The Small Claims Court said that the eviction is final and they can not do anything to allow time for the Fayetteville Police Department to release my items and keys that I may move my conveyances and power equipment from the property. I was told I have until the 5th of February to remove my property.or it will be reported abandoned.
