UNITED STATES CORPORATION COMPANY are cancelled effective October 26, 2018. The land known as North America/Northwest Amexem/Northwest Africa/The Northgate is now declared to be New Jerusalem and is the Empire of the Moors. All “US Banners of Amity and Commerce” are outlawed, No other flags, banners,

or

items of allegiance shall fly or be displayed in New Jerusalem besides the Moorish American Flag (red with green five pointed star). The Moorish American Flag will fly in all places currently occupied by the US Banner of Amity and Commerce and the US Banner of Amity and Commerce shall be permanently removed immediately. All citizens who are not of the Moorish American National (Melanin/Carbon dominant) Birthright and Bloodline are subjects of the Moorish American Nationals at all times. Anyone who obstructs, hinders, encumbers, speaks against, or resists the mandates of this affidavit will be seized by the Grand Army of the Republic, formerly known as the United States Military, and detained in a jail cell indefinitely. All immigrants who do not pledge sincere allegiance to the Moorish Flag and the Moorish National Republic Federal Government will be made subjects and are mandated to protect and serve the Moorish American Nationals upon our land. All who are CORPORATIONS, immigrants or not of Moorish American Birthright and Bloodline are debtors to the Moors. We remain in honor and governing accordingly. All goods and services are provided the Moorish American Nationals at North America/New Jerusalem at no charge to the Moorish Americans.

Aboriginal indigene affirmation and Dejure mandemus

ab initio Washitaw Constitution Law ov Love and Governing to be treated as 1099A/acquisition, A1099C, A1099K ,509-A, and 1041 nunc pro tunc et imperium UNDRIP Treaty 1996 and 2010: Article 28

1. Indigenous peoples have the right to redress, by means that can include restitution or, when this is not possible, just, fair and equitable compensation, for the lands, territories and resources which they have traditionally owned or otherwise occupied or used, and which have been confiscated, taken, occupied, used or damaged without their free, prior and informed consent.

WE THE ORIGINAL PEOPLE OF THIS LAND, SOME TIMES CALLED ABORIGINEES AND INDIGENOUS PRE-COLONS, RECOGNIZE THAT WE ARE THE CHOCTAW-WASHITAW THE ANCIENT ONES AND REMNANTS THEREOF; who now come together to bind ourselves together in love, to govern ourselves under Devine LOVE under this great CONSTITUTION of love for GOD and all of HIS creation above and below respectfully; INTERNATIONALLY: DECLARATION WE DECLARE OURSELVES IN OUR LAND TO BE A SOVEREIGN NATION IMPERIAL IN THE DIVINE RIGHTS FROM OUR CREATOR WHO SET US HERE TO RULE OURSELVES, FROM THE ALLEGHENY MOUNTAINS TO THE ROCKY MOUNTAINS, AND FROM CANADA TO THE GULF OF MEXICO INCLUDING EAST AND WEST FLORIDAES, BEING CREATED FREE AND BORN FREE AND SEPARATE FROM ALL OTHER NATIONS, WE HEREIN DECLARE OURSELVES INDEPENDENT ON OUR OWN NATIVE LAND THE CHOCTAW BROWN AND TAR COLORED WASHITAW de DUGDAHMOUNDYAH (MOUNDBUILDING) NATION, IN THIS AFMUURICAN CALLED AMERICA.

ARTICLE II LOVE shall prevail over all other law, and shall be our law, Imperial.



Section 1: Our Loving EMPIRE has an Empress whose bloodline is that Imperial bloodline, whether married or single, from on high to earth below, as a creative mother over her household with Love for all, by the LOVE of her CREATOR she shall rule with her people by her side.

1099A Washitaw Muurs/Moors have not abandoned their estate; Washitaw Muurs/Moors are the victims of genocide; and now Washitaw Muurs/Moors do reClaim/Revenue/ Acquire their lands /waters/air and resources;

1099C All debtors are against all WashitawMuurs/Moors are hereby and forever canceled;

1099K Debtor UNITED STATES and INTERNAL REVENUE SERVICE are trespassers on aboriginal lands and have not paid taxation/payment to the Empire Washitaw de Dugdahmoundyah and muur/moor heirs the amount required via Honorable Empress Verdiacee Tiari Washitaw Turner El Bey; whereforth all purported debt of muurs/moors must be settled/discharged/considered paid in full at all counters/registers/retailers/wholesales/clearing houses/ defacto government filings and recordings/all mailings and shipment stations and post;

509-A Moorish National Republic Federal Government, Universal Muur/Moorish Empire Republic, Yahudah Washitaw of East Terra, Flower of Life Amexem, and Empire Washitaw de Dugdahmoundyah are abOriginal indigene government entities, without the DEBTORS UNITED STATES and INTERNAL REVENUE SERVICE jurisdiction;

1041 Washitaw Muur/Moors are tax/payment exempt at all times, all points in time and all times.
