com ba honorable Muriel Montia El to declared that the following cases are hereby dismissed and deleted from all court proceeding in The State of North Carolina Cumberland County. in compliance with adjudication Case No. MACYW001260120 and trusts all bonds, arrest warrants, rulings and subsequent cases (as such 20CR051029) of the 'State actors' and The State of North Carolina and Cumberland County Courts are not lawful, in violation of UCc , ab original, and international law; and via writs of discovery the 'State actors' and The State of North Carolina and Cumberland County Courts have defaulted in proving jurisdiction; and Department of Motor Vehicle has defaulted by acquiescence . it is demanded that ab original marshals and Provost Marshal General :

1. go to the corporate offices of (see exhibit "a") and foreclose and execute the enclosed arrest and imprisonment commands. each and all corporate executive shall be imprisoned at Guantanamo Bay, Cuba as commanded.

2. each corporate executive is in breach of the Treaty of Peace and Friendship 1786/1836. The cause of action as outlined in each arrest and imprisonment command is unlawful occupation of sovereign original indigenous ancient ancestral land. Therefore, each and every corporation executive office is to be vacated by December 29, 2020 no later than 5:00 pm est. You are commanded to collect the keys to each building/office and turn over to the following Mohammedan Judge on or before December 31, 2020.

3. You are ordered to enter into each of the corporations and the city or town they are located and began peace keeping actions, using the resources that the former CORPORATION/CITIZENS have been unlawfully occupying. All resources shall be marked with the Moorish American flag so that said flag is easily seen by the public. All resources shall be for the benefit of the Moorish nationals.

You are ordered to distribute this affidavit of command to inform each and all agents, principals, assigns, employees, heirs, contractors, partners, board of directors, policy enforcers also known as police, sheriff or otherwise, that they are to put themselves back into alignment with the Treaty of Peace and Friendship. Any Moorish American national utilizing services from these former Corporations shall receive the highest level of services available, without charge to the Moorish American national. Any Moorish American national whose services have been disconnected, shall have their services restored immediately.

4. Any supporters of these corporations who speak out against or resist these lawful commands, must immediately leave North America or be removed and/or placed in Guantanamo Bay, Cuba until further notice.

5. All original people are not taxed. Any tax by way of fines, fees or any other such labels, taken from any Moorish American national, shall be returned within three (3) days of notice from the Moorish American national to do so, nunc pro tunc. The employers of such Moorish American nationals shall also be notified that all such taxes/fines or fees shall immediately cease against any Moorish American national. Any and all CORPORATE foreclosures shall immediately cease. Any and all attorneys, judges, clerks or agents who continue to violate this command, shall be removed from North America or detained at Guantanamo Bay, Cuba until further notice.

As outlined in the Universal Sovereign Affidavit of Command to appear in court, liens have been placed on all listed corporations/citizens and all commerce shall cease. Once these actions have been completed, we will send further commands where the safety and the distribution of natural resources are concerned.
