§28:9-521 Uniformed form of written financing statement – A filing office that accepts written records may not refuse to accept a written financing statement in this form and format except for a reason set forth in §28:9-516(b) entitled, "What constitutes filing; effectiveness of filing",(a) Except as otherwise provided in subsection (b), communication of a record to a filing office and tender of the filing fee or acceptance of the record by the filing office constitutes filing.

The financing statement also constitutes a fixture filing as to the collateral indicated in the financing statement which is or is to become fixtures.

§28:9-515 Duration and effectiveness of financing statements; effect of lapsed financing Statement.(f) if a debtor is a transmitting utility and a filed initial financing statement so Indicates, the financing statement is effective until a termination statement is filed.
