§28:9-521 Uniformed form of written financing statement – A filing office that accepts written records may not refuse to accept a written financing statement in this form and format except for a

reason set forth in §28:9-516(b) entitled, “What constitutes filing; effectiveness of filing”,(a) Except as otherwise provided in subsection (b), communication of a record to a filing office and tender of the filing fee or acceptance of the record by the filing office constitutes filing.

Except as otherwise provided in subsection (b), if the local District governs perfection of a Security interest or agriculture lien, the office in which to file a financing statement to perfect the security interest or agriculture lien is:

(2) The Mayor in other cases, including a case in which the collateral is good that are or are to become fixtures and the financing statement is not filed as fixture filing.
